FORGIVENESS AND REPENTANCE

"You cannot honestly forgive someone unless that person shows some remorse for what they did."

FORGIVENESS AND CONSEQUENCES

"If you really forgive someone, you would want that person to be released from the consequences of their actions."

The Bible clearly distinguishes between two very important words:

- _____ is my desire to see another person suffer for the pain he has caused me. The Bible consistently warns against harboring this kind of feeling in my heart.
 - **Romans 12:19 (CEV)** Dear friends, don't try to get even. Let God take revenge. In the Scriptures the Lord says, "I am the one to take revenge and pay them back."
- _____ is the payment God or society might demand from someone because of a wrong they have committed against us, or against society as a whole.
 - **Isaiah 1:17 (NLT)** Learn to do good. Seek justice. Help the oppressed. Defend the orphan. Fight for the rights of widows.

Go and be reconciled to that person. Then come and offer your sacrifice to God.
